The monthly meeting of the Parish Council was held on Wednesday 15th January 2025. Attended by: Cllrs. J Hobbs (Chair) J Phipps, K Boundy, N Steer, K Jones, J Payne, G Worden, R Savage, the Clerk and one member of the public. Apologies were received and accepted from Cllr. C Myers & Cornwall Cllr. S Tilbey.

The usual maintenance matters were covered. There is an ongoing issue at David's Lane with stone being continually washed out. Seven policies were reviewed by the Council. It is now time to seek formal quotations from the interested parties for the 2025 maintenance of the various community assets. The Clerk gave a report of the North Cornwall Community Area Partnership meeting that took place in December. A report was also given of a recent election training session. Local elections are taking place on Thursday 1st May 2025 – there will be full information available in due course. The Health & Wellbeing Project is partly complete. The Pump Track was opened just before Christmas – it is receiving much use and there are many happy bikers/skaters/scooters/riding it...children are even running around it! The multi-use games area (MUGA) has been completed in the most part; but the awful weather has delayed the top surface thus far.

PA24/09226 | Change of use to retirement livery, equestrian use, proposed field shelter, temporary rural/equestrian worker's dwelling, formation of new parking area and associated works. | Land West of Valley View Morwenstow Bude Cornwall. MPC Comments: Morwenstow Parish Council now feel able to support this application; with having viewed the County Land Agents report. PA24/09154 | Part conversion of store and extension to form new lobby and toilet facilities. | Community Centre Shop Morwenstow Bude Cornwall EX23 9SL. MPC Comments: Morwenstow Parish Council have no objections to the plans; but feel that the internal configuration could be better utilized if a cohesive approach had been taken. This could benefit all users of the Community Centre, for the best outcome.

Rural verge/hedge maintenance

(information taken from Cornwall Council factsheet).

We are now in hedge trimming season:

Who is responsible?

As the highway authority, Cornwall Council is responsible for the management of growth from the highway verge (excluding the A30 and A38 Trunk Roads, which are the responsibility of Highways England).

Growth into the highway from features such as Cornish hedges or trees on property boundaries is the responsibility of the adjacent land owner.

If growth is causing a safety concern the Council has the power to serve notice on the land owner if an informal approach is not successful. In the event it is deemed a hazard, then the council has the right to remove the growth without notice.

If you are requiring some maintenance to be carried out to your property that may have over hanging tree branches into the road for example; but you don't know who to ask.

As you may all be aware, Morwenstow now have defibrillators sited in Shop, Eastcott, Woolley, Gooseham and Cross Town, and one soon to be installed in Woodford.

This is a tremendous achievement since, Brad Olde, a local young fit 20yr old man, who had a cardiac arrest in 2015, and survived through life saving skills of CPR and emergency defibrillator.

We therefore felt it right to provide an **Awareness Day** on basic life saving skills for everyone from secondary school age and upwards. This will include, how and when to use a defibrillator plus Cardio-Pulmonary Resuscitation (CPR).

This will be presented by Jay's Aim, with video and hands on manikins to practice on. Plus a chance to get your blood pressure checked. You will also be encouraged to ask as many questions as possible.

EAST YOULSTONE COMMUNITY BENEFIT FUND



Fund Overview

The East Youlstone Community Benefit Fund, in Devon, has £15,000 available per year for community projects.

The Fund allows groups to apply for grants between £250 and £7,500.

There is one application round each year. The application closing date for 2025 is 26 March.

Project Purpose

Priority will be given to:

- Energy efficiency or renewable energy projects, such as insulation, efficient boilers or small scale renewable energy installations.
- Training or education projects, especially vocational training for unemployed young people aged under 25.
- · Projects for school age children, or older people.
- Any other community projects for the benefit of residents of the local area.

Eligible Organisations

Eligible Organisations, who can apply for funding include:

- Voluntary, community groups
- · Parish Councils
- Schools and educational establishments
- Social enterprises and Community Interest Companies operating on a non-profit-distributing basis.
 These are defined by Social UK as 'businesses that trade to tackle social problems, improve
 communities, people's life chances, or the environment. They make their money from selling goods
 and services in the open market, but they reinvest their profits back into the business or the local
 community'.

These organisations must have a minimum of three unrelated Directors, that also do not reside at the same address.

Applicants are required to have a written constitution, a set of rules, or a governing document and a bank or building society account, held in the name of the organisation, in place before applying for a grant.

Organisations that have already received grants from the Fund can apply for further grants each year.


